4. Full and free right and liberty to lateral and subjacent support and protection for the Property and any buildings to be constructed thereon from the retained land of the Transferor and any buildings to be erected thereon.

Full and free right and liberty for the Transferor and its successors in title to all or any part of the retained land of the Transferor to the free passage and running of water soil gas electricity telephone and all other services to be installed in the Property from and to the said retained land through along and into the sewers drains channels pipes watercourses mains wires cables and all other service installations which are now or may within the perpetuity period be in on or under the Property the Transferor and its successors in title contributing a fair proportion (according to user) of the cost of maintaining and repairing the same until (in the case of sewers and drains) such time as the same shall be adopted by the Local Drainage Authority as sewers maintainable at the public expense.
